I have acknowledged Barbara Baikie in my report to the NCWA December Board Meeting which is included in this Newsletter. We are all very grateful for her outstanding leadership over the last three years as NCWA President. In my view it is terrific that Barbara and Julie Morris remain as Board members and I look forward to working with them in the months ahead.

Since the December Board meeting Barbara and I have met with the Hon Kelly O'Dwyer MP office to discuss a range of issues including the mapping of domestic and family violence initiatives and the lack of progress of legislation announced in the May 2018 budget regarding the measures to tackle multiple superannuation accounts; changes to insurance for younger and inactive members; and restrictions on superannuation fees. Unfortunately, the legislation has yet to pass through the



Senate. The proposed measures to tackle the impact of superannuation fees on member balances including the cap on administration and investment fees on accounts with balances less than \$6000 at three per cent and abolishing all superannuation fund exit fees are two significant issues which affect many women. I have now written to the Shadow Minister for Women and cross bench Senators seeking support for the legislation to be dealt with and passed in the Senate early in the New Year.



The next NCWA Board meeting will be held on Monday 4 February 2019. In conclusion I would like to wish you all a very Merry Christmas and a safe, restful and enjoyable break.

NCWA Board Meeting - Monday 3 December 2018

Thank you to NCWA Board and members for electing me as President at the recent NCWA Triennial Conference held in October in Canberra. I very much appreciate your support and I will try to the best of my ability to continue the great work done by Barbara Baikie, Julie Morris and all former Presidents of this great organisation dedicated to the advancement of women and their families.

I would like to place on record my special thanks to Barbara for her leadership over the last three years and I am very pleased that she not only remains on the NCWA Board as Immediate Past President but was elected to the role of Standing Committee Coordinator. Congratulations also to Yvonne Robson and Angela Diamond re-elected as Secretary and Treasurer respectively. Congratulations to Merrill Cole who was elected as Vice-President and Julie Morris as a Board member.



Barbara will also be involved in producing the post-conference booklet with suggestions results and recommendations from the Triennial Conference. The Triennial Conference built on the mid-term Conference where NCWA examined the root causes of violence against women and homelessness for older women. The conference speakers included some of Australia's leading experts in the field, Members of Federal Parliament and academics.



During the Triennial Conference Dinner the inaugural NCWA Awards were presented. Congratulations to Doreen Todd NCWA Woman of the Year- a long-time member from NCW NSW, Michelle Pedersen NCWA Senior Service Award in her 20th year of service to NCW NSW and Erin Cunningham NCWA Encouragement Award from NCWQ. It was terrific to have His Excellency Governor General the Honourable Sir Peter Cosgrove AK MC (Retd) and Lady Cosgrove attend the conference dinner and Lady Cosgrove

presented the Awards.

Recently Barbara and I participated in the Office for Women Web Conference on gender-based violence. An overview was provided from Australia's appearance at CEDAW by Trish Bergin First Assistant Secretary Office for Women. Chantelle Stratford Branch Manager Family Safety Department of Social Security gave an overview of current Government initiatives related to countering gender-based violence and the panel responded to questions on notice received prior to the conference. It is my understanding that there will be a second Web Conference. However confirmation of a date has yet to be received.

NCWA Board Meeting - Monday 3 December 2018



October saw our first guest speaker for our major project this year Richard Griffiths from Safe Shelter. Safe Shelter is a men's only crisis accommodation provider however Richard had some great insights as he was one of the original volunteers to help set up the shelters. Richard spoke to us about the challenges faced by short term accommodation providers along with their original enquiries into women's shelters. Particularly relevant was the logistical and infrastructure issues that are unique to having a women's shelter, specifically the need for additional security as many women seeking short term or overnight accommodation may be fleeing a volatile relationship.

NCW ACT has in November written to the Minister for Women/Minister for Housing Yvette Berry regarding any current or future plans for using existing under-utilised buildings in the ACT for overnight accommodation for homeless women.

I also attended the National Inquiry into Sexual Harassment in the workplace which was hosted by the Australian Human Rights Commission. Much of the discussion was based around improved reporting, confidence and how we can ensure women are feeling supported to report. Ultimately it was also obvious that we need clearer direction for businesses to follow should a complaint arise, as well as clear expectations for what is expected for the harasser.

November saw us finish up our year with a small Christmas Lunch. It is pleasing to note the enthusiasm of the council in pushing through with our vision for next year.

- will be co-chaired by the Office for Women and the Coalition of Women's Domestic and Aboriginal Family Violence Services as the funded peak body
- will provide a channel for information about the work of the Chief Executives Group, which
 has leadership of the Framework, and the wider work of Government generally, allowing
 it to be communicated to relevant non-government agencies and for information to be
 shared between members about their own organisational initiatives
- will actively progress work through members' own workplaces and networks that achieves the outcome of reducing the prevalence of violence against women.

Finlater- Smith who stood down at the AGM after nine years in various positions on the National Board.

Delegates attended the conference from each state and the ACT and I would like to take this opportunity thank all delegates for attending and supporting the conference especially the large delegation from NCWWA. I was also delighted that two young NCWWA delegates attended – an opportunity provided to them by sponsorship from Curtin University. On behalf of NCWWA I thank Curtin University for their generous sponsorship.
