President's Welcome

elcome to the latest NCWA Newsletter. In the last few months much work continues to be undertaken by NCWA and the Constituent Councils. It has also been a busy time with AGMs for Constituent Councils and many Affiliate organisations.



A number of NCW Constituent Councils recently held AGMs, NCWQ elected Chiou See Anderson, NCWV re-elected Elisabeth Newman, NCWNSW re-elected Annie Keifer and NCWWA re-elected myself as President for the coming year. I note NCWSA has an AGM planned for early November 2019. Thank you and congratulations to all Presidents for all that is done for NCWA members across Australia.

It is always a busy time in the calendar year as many of the NCW Affiliate members hold AGMs and Constituent Council Presidents try and attend when possible.



I will be attending the ES4W AGM in Brisbane in November and I am also hoping to catch up with the NCWQ Constituent Council President during my visit. I am also a participant in the Women Leaders Institute "Women in Leadership" 2-4 December 2019 Perth Conference. Leading speakers include Professor Lyn Beazley, former Chief Scientist of WA, representatives from Westfarmers, Fortescue Metals Group. BHP, Aurizon, the Managing Director of Bankwest, academics and government

departments. Over 40 speakers will participate during the conference and attendees include Tronox, Crown Resorts, Water Corporation, Orica, Perth Airport, Edith Cowan University. CSW Australia, Google, RSM, Suncorp, Western Australian Golf Club, Ironbark Aboriginal Corporation and a large number of government departments.

My involvement is in the panel session: "Owning the Strengths that Women Bring to Male-Dominated Industries"- it is a great opportunity to ensure National Council of Women Australia is better known within the Corporate community. The CEO Chamber of Minerals and Energy is also a

participant in the panel session as is a representative

from BHP.

NCWA will be preparing and providing a submission to the Joint Select Committee on Australia's Family Law System. Submissions close on 18 December 2019- if any Constituent Council would like to make a contribution then it needs to be with me no later than 6 December 2019. While the Australian Law Reform Commission recently released a report with recommendations this inquiry presents the opportunity to reform the Family Law System- many of us continually hear about the dreadful experiences from NCWA members, friends and family members who have or are going through the current system.



The interim report into Aged Care Quality and Safety was handed down on 31 October 2019. The report is shocking, describing suffering, abuse and neglect for many in residential aged care which is no surprise to me nor I suspect many, many Australians who have experienced poor care for a family member. Finally the Commission has found what many, many people already knew that the sector is failing to meet the needs of the nations most vulnerable. The system is in crisis and does need urgent attention, hopefully the government will respond with urgency. While an immediate significant boost in funding is needed for home care packages, I firmly believe there is a need to ensure consumer representation is included on all the government Aged Care Committees and Councils.

NATIONAL COUNCIL OF WOMEN AUSTRALIA PRESIDENT'S REPORT

NCWA Board Meeting – Monday 21 October 2019

hank you to all Board members for agreeing to trial a change of date for the NCWA October 2019 meeting. It certainly does make it easier for me given my other commitments earlier in the month.

Since the last Board meeting I have visited Adelaide to organise a venue and date for the NCWA 2020 Mid-term Conference. A contract has now been signed with Rydges South Terrace Adelaide. The Mid-term Conference will be held on Friday and Saturday 15 and 16 May 2020 with a NCWA Board meeting to be held on the



afternoon 14 May 2020. Thank you to Fiona Dorman who was very helpful during my visit to Adelaide.

During my time in Adelaide in September I was also able to attend a NCWSA General meeting, meet with some of the Executive members and then speak at the meeting. I was delighted to meet those NCWSA members in attendance and also take along a young woman who has now joined NCWSA.

I was also invited to attend the NCWNSW AGM in Sydney in late September and was able to attend and speak at the meeting. I was also scheduled to visit Hobart and attend a NCWTAS meeting. Due to last minute events I was not able to make the meeting. I am still hoping to visit Hobart, however it will now have to be early next year now. Congratulations to Annie Keifer on her re-election as President of NCWNSW.



I recently was invited to attend a debrief at the Department of Foreign Affairs in Canberra on the outcomes of the 16th Australia-Vietnam Human Rights Dialogue and the 6th Australia-Lao PDR Human Rights Dialogue which were both held in August 2019. I am concerned about some of the issues not raised in the Australia-Vietnam Human Rights Dialogue- eg. in relation to the number of different minorities especially the lack

of recognition of the Khner Krom, definition of disability (a very long way behind Australia) child labour and any development of domestic and family violence policy. Such a dialogue is very important however I do think that civil society should be involved in such meetings- it is certainly something that in my view NCWA should raise with the Minister for Foreign Affairs Unfortunately while I had a meeting with Senator the Hon Marise Payne in her capacity as Minister for Women recently- thank you to Julie Morris who attended with me- the debrief was after the meeting date.

White Ribbon recently went into liquidation. Where was the Board and its Directors? After a cursory glance it becomes very apparent that the total cost of administration and employee costs for White Ribbon accounted for 96 per cent of the Charity's reported revenue. My understanding is at June 2018 the workforce was 47 people and although the workforce was reduced to 28 staff at the time of liquidation- why would White Ribbon need 28 staff let alone the original 47.

White Ribbon described itself as a global social movement raising awareness of domestic and family violence and a not -for-profit charity. In the last twelve months alone, it raised 6 million dollars but spent 6.9 million dollars. A staggering amount for raising awareness- just think what 6 million dollars would do for front line services on the ground. It is time for a detailed mapping of all government funded domestic and family violence programs – programs must perform- while there are a number of excellent programs in operation, unfortunately there are many programs where administration and staffing costs swallow up most of the scarce resources.

In September NCWACT headed a proposal for the implementation of tiny homes on existing women's community service providers land. This proposal however was rejected by ACT housing as they would not allow the committee to use the land as it was slated for future development (the purpose of tiny homes is for such land when not in use and then moved on!)

NCWACT continues to talk to stakeholders in this industry and will continue to pursue Tiny homes as an option for homeless women in the ACT.

Emergency shelter accommodation for women - NCWACT continues to make this a priority project

Sleepbus provides a safe, temporary overnight accommodation service, getting people off the street by offering an immediate, first stop, cost-effective solution for our society's most vulnerable; catching them early until they can get back on their feet.

NCWACT has commenced fundraising for a women's only sleep bus to be brought to Canberra. The bus will be able to accommodate both pets and children. This is a huge advantage over the Safe Shelter proposal using churches as children or pets would not be able to use the church halls. \$100,000 in donations need to be raised to order the sleep bus and will take approximately 12 weeks until it is delivered. This service would operate 365 days year. This is a very exciting initiative I look forward to updating you on our progress.

Our members and delegates at the meeting heard about the works of NNCWA, plans and strategy for the future and of President Nolan's attendance and participation at CSW in New York in early 2019.

Members of the N.C.W. SA Executive and long-time members of the organisation were invited by our Patron-in-chief, Mrs Lan Le to morning tea at Government House on Friday October 11th, 2019. Mrs Lan Le welcomed NCWSA and was gracious in her address to us regarding the work of NCWSA, our affiliated organisations and her belief that our good work continues to be important in the wider community.

Sarah Annicchiarico, Wallmans Lawyers was our Guest Speaker at the October 10th Council meeting. Her topic, "Good Governance Principle for Not-for-Profit Boards", covered topics such as Directors Duties, liabilities, dispute resolution, attendance requirements, Accountability of members, suitability of responsible persons, statutory duties and Constitutional reviews. The nearly 30 attendees from across our affiliated organisations had many questions, both specific and general, including topics such as "What is the maximum number of proxies a person can hold?" and what is the minimum number of persons that legally make a quorum?

The most recent **Key Partner Network meeting** was held on Thursday October 3rd, 2019. The Network is convened by the Office for Women and the Coalition of Women's Domestic Violence Services.

Representatives are from a range of service and advocacy organisations such as: Women's Legal Safety Services, Zonta International, National Council of Single Mothers and their Children Incorporated, KWY Aboriginal and Torres Strait Islander Family Services, Aboriginal Legal Rights Movement (ALRM), Multicultural Communities SA, YWCA, Community Transitions, Working Women's Centre, Catherine House, Youth Affairs Council SA, Multicultural Youth SA, Women's Safety Services, Yarrow Place and Uniting Communities.

The aim of the network is multi-fold, one being to convene representatives of organisations and representative voices working in Domestic, Family and Sexual Violence services and supporting organisations, with the Fourth Action Plan as the basis for discussions.

Some key points from the most recent meeting included:

- The announcement of the Joint Parliamentary Inquiry into Family Law and Child Support. Since 2007 there have been at least 8 inquiries. Discussions covered the proposed scope of the inquiry and when the deadlines for submissions would be opened and closed (not available at the time of the meeting).
- There is debate in the community as to whether groups should participate in this inquiry. All groups are encouraged to participate to make their voices heard.
- The Office For Women are continuing work on the Women's Employment and Leadership Strategy. The focus being on working with Small to medium enterprises as there are many women working in SMEs whose roles are more vulnerable to changes on market forces.
- Discussions included the need for a fundamental change in thinking at a community level that
 "women need fixing" when faced with situations of gender inequality, gender violence, leadership
 and employment etc. Women are already confident, skilled and experienced in their work and
 personal lives but the barriers to achieving goals is influenced by persisting attitudes within
 workplaces and the wider community.
- The second Safety Hub has now been opened in Berri with services being co-located in the one place; the aim to reduce times in accessing crisis support and support services in general.
- These hubs serve also to provide information to people before a crisis point.
- The Office for Women encourages increased discussions on sexual violence. Sexual violence is
 perpetrated as a stand-alone offence and related to Family and domestic violence. The discussions
 were framed in light of the National Community Attitudes towards Violence against Women Survey
 (NCAS). Data shows that "while Australians' attitudes to violence against women and gender
 equality are improving, there are some disturbing trends."

On Saturday October 19th, 2019, NCWSA held our seminar entitled "Everyday Heroines: Drivers for Change". We were delighted to host approximately 40 attendees and hear from speakers Dr Jane Lomax-Smith AM (Former NCWSA Patron, Lord Mayor of the City of Adelaide), Leah Marrone (Vice President Australian Women's Lawyers), Felicity Birse (Year 9 Student, "Visions of her Future"), Ruby Eckermann (NCWSA Lady Moulden Award Winner 2019), Thilan Legierse (Former UN War Crimes Lawyer in the Hague) and Terese Edwards (CEO, National Council of Single Mothers and Their Children Inc). The day featured incredible presentations, robust discussion and insightful questions to our speakers.

NATIONAL COUNCIL OF WOMEN TASMANIA NCWA Board Meeting — Monday 21 October 2019

uest speaker at our August General meeting was Leanne McLean, Commissioner for Children and Young People (Tasmania).

Leanne McLean, the current Commissioner of Children, in Tasmania, was appointed in 2018. The legislation creating the role of the Commissioner for Children was updated in 2016 and strengthened the independence of the Commissioner, whose chief concerns are the rights and wellbeing of children in Tasmania. There are 112,340 children and young people aged between 0-17 in Tasmania.

They have:

- A right to non discrimination
- A right to have their best interests taken into account
- A right to life survival and the right to have a say.

The Commissioner began by giving us a snap shot of the situation of children in Tasmania at this time.

10% of young people aged between 0-19 in Tasmania identify as Aboriginal/Torres Strait Islanders. 50% of young people live in local government areas with an index of relative socio-economic disadvantage.

88% of pregnant women attend ante-natal visits in the first 14 weeks of pregnancy 90% of families attend the 8 week child health assessment.

80% of Tasmanian children are developmentally on track. (Brief notes from her talk.)

Another area of concern for NCWT is Elder Abuse.

The Commissioner for Ageing, Kay Patterson was recently in Hobart to promote legislative changes to reduce elder abuse. The recently released bookmark is a step in the right direction. The bookmark is designed to be unobtrusive as against a fridge magnet. The bookmark asks questions on the elderly's personal situation and gives a phone number to ring for assistance. The Commissioner is also advocating for one document incorporating Power of Attorney's Australia wide to cover all issues including medical, financial and legal issues.

I note in the most recent issue of Women's Weekly an open letter was sent to the Prime Minister signed by the Australian Banking Association and Economic S4W. The WW article also requests an Australia wide Data Register to check if POA's documents are legitimate and current.

I recently attended a dinner of one of our members the Soroptimist International of Hobart, who were celebrating 70 years operation.

n the 19th August we held one of our major annual events, namely *My Vote My Voice* in the Legislative Council Chamber, Parliament of Victoria, This year's theme was: *Male and Female Youth as Future Voters*, drawing on NCWV's partnership with Australian Local Government Women's Association, the Victorian Electoral Commission and the League of Women Voters' Bessie Rischbieth Trust. The event commenced in Queen's Hall with a welcoming speech from the Hon Gabrielle Williams, Minister for Women, Youth and Prevention of Domestic Violence. We than moved to the magnificent Legislative Council Chamber where Ms Amy Carpenter, Education Coordinator, Victorian Electoral Commission set the scene with a speech in which she stated how annoyed she gets when hearing people say that young people are apathetic and not interested in what is going on beyond their world. Students from 12 diverse schools made excellent presentations based on their research of the theme. It will be hard to select the award winners. The panel of eminent persons when commenting on the presentations, said the one common element that came through was the need for more 'Civics and Citizenship' content in the core curriculum.

ince the last NCWA Board meeting NCWWA has continued to hold monthly meetings with a meeting held in late August and September. At the August meeting the special guest and guest speaker was the Hon Cheryl Edwardes- Cheryl spoke about her role as a Member of Parliament, a former Attorney General for WA and her interests since that time. Cheryl also spoke about her role as Chairwoman
