

# National Council of Women of Australia (NCWA) Application Form for Attendance at the ICW General Assembly 2025

The International Council of Women (ICW-CIF) will hold the General Assembly 2025 from 23 to 29 June 2025 in Marrakesh, Morocco.

The General Assembly of the ICW meets every three years to evaluate the status and development of women around the world, assess the activities and progress of ICW affiliates in promoting the current triennial theme, and establish a new triennial theme. The Regional Councils also use this global gathering to hold their meetings. Another key objective of the conference is to strengthen this global network of women by reinforcing ties of friendship and cooperation among affiliate members.

The event will feature a hybrid Annual General Meeting (AGM), where attendees can participate in person or via Zoom.

**Application Information:** An official delegation consists of ten members from International National Councils of Women. As in years past, NCWA has required applicants to gain approval from their Constituent Council's Executive/Board to join the official delegation.
