Dear NCW presidents and sisters,

Different people have different understanding of the justification, or lack thereof, for the Russian invasion of Ukraine. The causes of war are always complex. My focus here is not to join what appears to be essentially the global condemnation of Russia's aggression, but to emphasize the growing number of those who suffer.

We cannot help but feel enormous sympathy for all the casualties, particularly for all the innocent women and children whose lives have been turned upside down if not destroyed. As members of the International Council of Women, our hearts ache for them. When we see clips of fleeing moms with babies in arms, it hurts us deeply. We can literally feel their fear and anguish. When we see women hand in hand with their young family, walking mile after mile to safety in tears, we cry with them. Regarding neighboring countries which have graciously taken in hundreds of thousands of refugees, potentially millions, we express our gratitude and appreciation for their kindness.

Our strongest hope is that there can be a peaceful, just and speedy resolution of the conflict. But as we move toward that goal, it is imperative that we remain vigilant to the plight of women and children. They need and deserve our strongest support.

Humanitarian action, we believe, is an important role that national councils of women can play in influencing policy. As members of the global community, we at the International Council of Women will redouble our efforts to enforce the various international humanitarian and human rights laws and conventions that protect the rights of women and girls during and after conflicts. We will also do our best to stop the war and take the lead in establishing permanent peace with the power of women's cooperation and unity.

ICW Statement to mark International Women's Day 2022

The International Council of Women, a Non-Governmental Organization in consultative status with the United Nations Economic and Social Council, has worked diligently to advance equal rights for women since its establishment in 1888. The Council is steadfastly committed to full implementation of the Sustainable Development Goals by 2030, advancing the status of women, and the removal of all forms of discrimination against women and girls. The International Council of Women's objectives are definitely in line with the theme chosen by UN WOMEN to mark the International Women's Day 2022: "Gender Equality today for a sustainable tomorrow"; a topic of primary importance for the building of a more sustainable future for all.

Gender inequalities still remain deep-rooted in many societies. Structural barriers in the economic, social, political and environmental spheres produce and reinforce these inequalities,

resulting in a lack of equal access to the workforce, as well as occupational segregation and gender wage gaps. Very often, women and girls are still widely denied access to basic education and health care, are victims of domestic violence and discrimination, and are under-represented in relevant important political and economic decision-making processes. Despite the many formidable challenges, women have a critical role to play in all the Sustainable Development Goals; and the need to recognize gender equality is especially represented in Goal 5. This goal, known as "the stand-alone gender goal", is dedicated to achieving gender equality and empowerment of women and girls, and detailing within the single goal a full range of issues of general concern. It is true that effective actions have brought some positive change. However, all too often the hard-earned achievements in the field of Gender Equality have suffered from a serious backlash; particularly in the last two years of a worldwide pandemic and an increase of violence and unrest in certain parts of the globe, as the case of Afghanistan has shown, and now the crisis in Ukraine.

Sustainable development is tightly interlinked with both gender equality and peace; without peace there will not be a sustainable tomorrow. Sadly, there are too many places of conflicts around the world to mention one by one and the most recent news

are filled with heartbreaking images of many women and children trying to flee from Ukraine in search of safety and survival. Women and girls suffer inordinately during and after armed conflicts, losing their fundamental human right to live in safety and peace. They have to face the overwhelming tasks of holding their families

together after displacement, of providing food, clothing and shelter in destroyed areas, and the heightened risks of becoming widowed, as well as being victims of sexual violence and diseases. Security Council Resolution 1325 clearly acknowledged that women's participation and empowerment are critical components for the maintenance of peace and security. Yet the gender gap in these peace mechanisms still persists. As such, members of the global community must hasten their implementation of this important Security Resolution through enforcing the various international humanitarian and human rights laws and conventions that protect the rights of women and girls during and after conflicts, taking special measures to protect them from all forms of violence, protecting the needs of women and girls in refugee camps and settlements and including women as full and equal participants in peace processes, including disarmament and rebuilding mechanisms.

The International Council of Women's affiliates diligently continue to struggle for women to gain opportunities to play a decisive role in addressing the challenges in the fields of politics, economics, and climate change. Clearly, women are indispensable in this process and must be included as strategic partners. The building of solid partnerships is unquestionably a key component of ensuring a positive sustainable future for all. Thus, there is a fundamental necessity to bring together a whole range of relevant participants: institutions, international and regional organizations, governments and even members of local communities, in order to form alliances and direct efforts towards achieving gender equality.

Long-term advocacy and actions, in conjunction with specially designed policies and measures to promote the inclusion of women in the economy and polity, continue to be an urgent necessity that will contribute for a sustainable tomorrow. We need to ensure that women and girls are at the very heart of this matter, because the inequities and inequalities impacting on their health, opportunities and wellbeing are so persistent. This is, unfortunately, a much unfinished business and this should be the world's greatest challenge as we chart the path ahead.

To work towards meeting such challenge, one must recognize that good education is certainly a prerequisite for the fulfillment of human gender equality potentiality. However, although the gender gap in education is gradually closing, far too many girls are still denied schooling or have to drop out prematurely with few skills and even fewer future opportunities. With two thirds of the world's illiterate being women, overall gender equality cannot be achieved.

Therefore, overcoming the gender inequalities and critical barriers, which prevent women and girls from exercising their rights and empowering themselves, must be at the heart of our efforts to create sustainable and resilient societies in order to build a sustainable future for us and our future generations. The International Council of Women joins UN WOMEN in stressing the belief that "Without gender equality today, a sustainable future, and an equal future, remains beyond our reach". We at the International Council of Women recognize the supreme challenge of the times. Our hearts go out to those of you who have lost loved ones, those of you who have felt economic decline, those of you who have been denied a good education, those of you who

have lost security and safety, those of you who have felt deterioration of equal rights and all the other despicable baggage that has come along with this pandemic and the increase in climate disasters, gender- based violence and armed conflicts around the globe. We feel with you, but don't let this defeat you. Rather than despair, we believe it is time to redouble our efforts to help build a just, peaceful and sustainable future. It is time to dig deep to help create what we know to be a better world.






NCWQ February 2022 Report


The 2022 NCWQ Bursaries will be opened in early April and preparations are already underway.



Two NCWQ associate members were appointed Magistrates at the Southport Courts this week. Dzenita Balic, a Bosnian refugee who came to Australia as a child with her parents and siblings, was from the Office of Public Prosecutions and Veena Jattan Goverdhan, a commercial lawyer, who migrated to Australia from Fiji when she was 14. Their welcome ceremony was streamed live on YouTube and both gave wonderful, humble speeches. Interestingly, all 3 Magistrates appointed are women.

Since attending the NCW council meetings from NSW, Vic and SA, I discussed the format of these meetings with NCWQ and we have now agreed to invite our affiliates and members to join us for our monthly council meetings, too. This will now enable us to invite past NCWQ Presidents and committee members to be a part of our future.

NCWACT February 2022 Report

The National Council of Women of ACT met for the first time in February 2022 with guest speaker Kirsty Mead from Pelvic Pain Australia. Kirsty is very keen to involve ACT schools in their program to raise awareness of pelvic pain in all its manifestations but is experiencing difficulty in gaining co-operation from the ACT government as they already have their own munich small program run out of the major hospital. One of our members has contacts within the ACT government and has undertaken to raise this issue with the Minister for Women in the hope of achieving some degree of co-operation and of course funding.

In November 2021 the NCWACT made a submission to the Justice and Community Directorate regarding a number of issues surrounding the prison in the ACT. We have previously been involved in issues surrounding women in the prison and our submission this time focussed on the intensive corrective orders which are used as an alternative to sentencing and their success/failure. Our submission was accepted along with 28 others. I was able to watch the live video stream of the hearings over two days and there are a number of major issues which need to be addressed to make sure that the intensive corrective orders are effective and serve their purpose.

We will continue to engage with the Justice and Community Directorate regarding issues within the prison and participate in further enquiries when they arise. There have been a large number of enquiries into the running of the prison during its existence (13 years) which seem to raise more issues than solutions.

Our focus for this coming year will continue to be homelessness and further engagement with Aboriginal and Torres Strait islander Women in the ACT.

125th (+) Anniversary Celebration, 24 February 2022 at QVB Tea Room: This event is going ahead and with numbers getting up near 120 we are sure it too will be a success. Starting at 11.30am with plenty of time for chat and greetings before the arrival of Her Excellency and Mr Dennis Wilson. Geraldine Doogue AO is the Guest Speaker, our Patron is also going to speak and we will have some music items from Clare McCallum,

cabaret artist and yes, we will all be able to sing the National Anthem (both verses).

KWOOP (Keeping Women Out Of Prison Coalition): Confirmed Parliamentary Breakfast with Robert Tickner, Chair, Justice Reform Initiative is to go ahead on March 2022. The program deliverers are still active, although have been under reduced operations due to COVID19.

NCOSS: NCW NSW supported the NCOSS Pre-Budget Submission as it aligned with NCW NSW aims.

Affiliated Organisations: It was great to see so many of our Affiliated Organisations at our "Celebrate Being Australian – We are all part of the story" in January. Positive feedback has been received and I hope that it will give a big boost in their own efforts and activities to launch them into a very successful 2022.

Our thoughts are with our Ukrainian diaspora as they deal with the uncertainty for their families and friends in Ukraine. NCWV February 2022 Report

1. NCWV - 120th Anniversary Celebrations in 2022

2022 promises to be a special year celebrating the 120th anniversary of NCWV inauguration in 1902. The four original affiliates who met on 19 March 1902 were:

- the Austral Salon of Music, Literature, and the Arts.
- the Melbourne Jewish Women's Guild.
- the Young Women's Christian Association Y.W.C.A; and
- the Women's Christian Temperance Union WCTU.

Our 61st Annual Australia Day Pioneer Women's Ceremony to celebrate our founders and the women who continue their work today, has been rescheduled due to the pandemic from January to Saturday 26 March 2022 Our keynote speaker, Dr Judith Smart AM (co-author of the history of the National Council of Women of Australia, Stirrers with Style), will give an overview of the history of Victorian women's organisations. Then a panel of speakers will talk about the founders of NCWV (Janet Lady Clarke, Women's Christian Temperance Union, YWCA, the Melbourne Jewish

Women's Guild and the Austral Salon of Music Literature and the Arts).

We have approached the ALGWA Victoria about the possibility of tree planting – 120 trees as green memorial regarding suffrage and our anniversary.

2. Anniversaries

- 19 March 1902 foundation of NCWV
- 12 June 1902 [white] women's suffrage in the Commonwealth of Australia under the Franchise Act • 21 May 1962 - all Aboriginal and Torres Strait Islander people granted the option to enrol and vote in federal elections. On 21 May 2022 it will be the 60 years anniversary.

Might NCWA make a similar approach to ALGWA on a 'whole of Australia basis' regarding 120th anniversary of suffrage? Or other states join this initiative?

Should we be contacting other peak alliances about how to commemorate the 120th of white women's suffrage?

3. Return to virtual meetings

Thursday 3 February Council Meeting featured Coral Ross OAM

Coral spoke about her 2020 Churchill Fellowship research and recommendations to improve gender equality. Coral has had an esteemed career in local government and was previously the National President of the Australian Local Government Women's Association and ALGWA Victorian President – she is currently the National Treasurer.

Responding to the unacceptably slow pace of change towards gender equality in Australia, leading organisations, which represent over 500,000 women in the workplace, have come together to form the AGEC, a national not-for-profit organization.

We considered activities of other NFPs and public organisations with programs relating to gender equity for women and girls in Victoria to discern alignment and therefore alliances, and areas of differentiation that require our focus.



Tasmanian opened its borders just prior to Christmas. The check in app was made redundant as notification of cases except to the person concerned was discontinued. This caused many people not to venture out to restaurants or other indoor settings. The effect was, Hobart has become very quiet and many businesses have been struggling to stay afloat.

The 2022 year has well and truly begun. Finally Western Australians have received some good news with the Western Australian hard border finally coming down on 3 March 2022. For many it has not come soon enough – Australia is one country and as such many Western Australians have been severely disadvantaged for many months (or should I say two years) during the CODID-19 pandemic and more recently with the Omicron variant.

The Western Australia economy has suffered predominately with a severe staff shortage, city workers have not returned from working from home and many people remaining hesitant about going out and continuing their normal routine because of fear promoted well by the Western Australian Premier and many in his government. Distinguishing between double vaccinated people and those un-vaccinated (some of those people waiting for Novavax which has finally become available) employees have suffered all kinds of abuse for just trying to implement government

NCWWA is very pleased to see the removal of the Superannuation Guarantee \$450 threshold legislation pass the Federal Parliament in its final sittings before the 2022 Budget in late March. The resolution regarding the removal of the threshold was an NCWWA resolution and it is always terrific to see government act on policy from individuals in the community. The requirement to earn at least

\$450 per month from one employer to receive superannuation payments will be scrapped from 1 July 2022. Low income earners, estimated to be about 300,000 will benefit from the scrapping of the \$450 threshold, with 63% of those believed to be women.
